## 08 Seasonal Rental Agreement for Driftwood Camping Resort, Inc

Rentals are based on a family of 4 (parents & dependent children). **All persons not listed on this contract are considered guests.** Guests & any vehicle without a sticker should arrive during office hours. *Site holders will be charged for all guests arriving after hours at overnight fee.* If you do not wish any of your guests to be charged, please indicate on the reverse side. The charges will be added to your site. If the car pass is returned to the office **by the guest** within the hour, there will be no charge. This is a privileged procedure and will be discontinued if charges are not taken care of promptly. **Day visitors** must depart by our quiet hours of 11 PM. If an unregistered guest is found in the park, there will be a \$75.00 charge. A second offense will result in your expulsion from Driftwood. The gate is electronically surveilled, anyone illegally obtaining entrance is subject to expulsion from the campground.

**Pool & Lake Rules:** 1) NO lifeguard on duty 2) Persons under the age of 16 must be accompanied by an adult 3) No swimming alone. 4) Owner or Manager must be on premises. Additional rules are posted in swim areas.

**Additional Information pertaining to rental at Driftwood:** This agreement is in conjunction with the seasonal regulations on the annual rate sheet.

- Loud and obnoxious behavior will not be tolerated at any time. Complaints that result in police response are cause for expulsion.
- All vehicles MUST display applicable pass (seasonal or visitor). Vehicles are not to be parked on vacant sites or in the road.
- There is NO driving into the campground during the closed season. You must park your vehicle and walk to your site.
- No motorized vehicles are to drive in the campground that are not street licensed and insured. Proof must be on file at the campground office. All drivers must be licensed
- Boats (or any other fuel powered recreational vehicles) or their trailers will no longer be allowed to be parked on site at any time. They must be parked in the storage lot. Space is limited
- All vehicles, trailers, boats, etc. in storage must have paperwork on file in the campground office prior to parking on the lot.
- We follow NJ state law regarding helmet use on bicycles, mopeds, etc. Lights are required at dusk. No skateboards after dusk.
- Pets are permitted, however: They must be on a leash not exceeding 8'. They must be picked up after. They are NOT permitted in pool, lake & beach areas.
- Dumpsters are for household type garbage **ONLY**. Leaves & Brush are **NOT** to be placed in dumpster or placed on any other site.
- Washer/dryers and dishwashers are not permitted.
- One shed is permitted. It is to be NO larger than 6 x 8. Material & Location must have office approval in writing.
- Rental of your trailer is not permitted.
- Trailer owner agrees to carry his own insurance to protect against damages. Driftwood is not responsible for loss of any kind.
- Management reserves the right to annually inspect any trailers or sheds to see if they are in conformance with campground policy.
- Site fees are to be paid on time. If not received within 15 days a \$50.00 late fee is incurred and interest will accrue at 1.5 % per month (18% APR). Not receiving a bill does not relieve you of the responsibility of paying on time.
- This Lease is an annual lease, renewable at the discretion of management. This lease is non-transferrable.
- Sale of your trailer on site must have prior office approval and meet eligibility requirements.
- On your final departure from Driftwood, your site must be cleared of possessions & debris or this will be disposed of and you will be charged for the labor and dump fees.
- Rules & Regulations are subject to change at the discretion of management.

***Site Renter will inform family & guests of the rules & regulations. The site renter is responsible for their actions.***

**I have read, thoroughly understand and agree to the terms applicable to being a seasonal camper at Driftwood Camping Resort. I understand further that non-compliance of any conditions (by myself, listed family members or guests) may result in forfeiture of camping privileges, refund is at discretion of management. I agree to pay the site fee when due (a deposit for six month sites is due by 9/15 for the following season) and I realize that I may lose the campsite for delinquent payment of fees.**
